TENDER NOTICE

Sub: Prequalification of Interior Contractors for Repair & Redevelopment of the office of Directorate of Industries, Trade & Commerce (D.I.T.C), Govt. of Goa.

The Goa industrial Development Corporation a Govt. of Goa undertaking desires to Repair and Renovate the Office premises of the Directorate of Industries, Trade & Commerce located at Udyog Bhavan, opposite Azad Maidan, Panaji, Goa.

The Repair and Renovation work will involve repair of the leakage in the external walls, redoing of the aluminium windows, providing new flooring, furniture, false ceiling, lighting, electrification, computer networking, painting, polishing, redoing of the toilets and other interior related allied items. The estimated cost of the project is Rs. 1.5 crores.

The completion period for the job will be **strictly 100 days**. Penalty clause will be invoked for delay in the completion.

The Goa industrial Development Corporation invites sealed bids for prequalification from eligible contractors for the work of "Repair & Redevelopment of the office of Directorate of Industries, Trade & Commerce (D.I.T.C), Govt. of Goa.

MINIMUM ELIGIBILITY CRITERIA FOR BIDDERS

TECHNICAL CRITERIA:

The bidder should have in the last 5 years successfully completed as a prime contractor at least one similar work of value not less than Rs.150.00 lakhs or two similar works each of value not less than Rs100 lakhs.

FINANCIAL CRITERIA:

- a. The bidder should have an average annual turnover of at least Rs. 75.00 lakhs during the immediate last 3 consecutive financial years. Audited profit & loss account and Balance Sheet for immediate last 3 consecutive financial years should be submitted along with the bid.
- b. The bidder should have a solvency of not less than Rs. 60.00 lakhs from a Nationalized Scheduled bank.

All the completion certificates/ documents enclosed for the technical / financial criteria shall be either in original or true copy of the same duly notarized or attested by gazetted officer. The bids duly sealed in an envelope super scribed "Prequalification of Contractors for Repair & Redevelopment of D.I.T.C Office" shall reach the GIDC office on or before 29.09.2009 upto 15:00 hours.
